

### Ministry to issue daily bulletin for fish prices

#### Initiative is aimed at preventing unjustified increases in fish and

The Ministry of Commerce and Industry (MoCI) has announced the launch of an initiative that sets the maximum prices of fish and seafood and regulates their sale based on a mandatory bulletin.

In a statement yesterday, the ministry said the initiative is aimed at preventing unjustified price increases, cracking down on monopolistic practices and ensuring consumers' right to purchase goods at reasonable prices.

The prices will be published daily following an auction that will take place under the supervision of the MoCI. The daily fish and seafood price bulletin will be introduced from tomorrow morning.

The initiative comes within the framework of the ministry's role in overseeing and regulating markets in line with its jurisdiction and taking the necessary measures to protect consumers, combat commercial fraud, promote competition and prevent monopolistic practices, the statement notes.

Through the initiative, the MoCI said it aims to maintain a balance in the rela-

tionship between consumers and suppliers or merchants in order to protect the commercial and economic environment.


"The ministry will issue the daily bulletin that sets the maximum sale prices of fish and seafood. The prices outlined in the bulletin issued on the last business day will apply to official holidays," the statement points out.

The initiative requires retailers to place a label in a prominent place indicating the type and selling price of each type of fish and seafood.

Retailers shall not charge prices higher than those set in the daily price bulletin and shall only sell healthy and consumable fish.

Traders shall also refrain from taking any measures or actions aimed at raising the prices of fish under any pretext while committing to providing any additional service in line with the prices outlined in the mandatory bulletin.

The initiative emphasises the importance of abiding by the maximum prices outlined in the daily bulletin, displaying the bulletin in a prominent and clear place and providing the buyer with a detailed invoice. It also compels merchants to comply with the storage conditions of fish and seafood in accordance with applicable health and safety standards. To Page 5

### Qatar, Angola usher in new phase of ties

### Nod for index to measure extremism leading to violence

First international conference on "studying the causes of extremism" concludes in Doha Violent extremism one of the most serious challenges facing the world today

The first international conference on "studying the causes of extremism" concluded yesterday in Doha, with participants agreeing to launch an index for measuring extremism that leads to violence.

Such an index is expected to make data on this phenomenon available to researchers and policymakers.

Organised by the Social and Economic Survey Research Institute (SES- RI), the two-day conference witnessed the participation of several international experts, scientists, researchers and decision makers from 20 countries around the world, in addition to the participation of the Counter-Terrorism Executive Directorate at the Security Council.

A statement issued by the organisers said the participants agreed to take steps towards the development and implementation of a global index of extremism that uses data collected from representative surveys to measure violent extremism in all countries and at different times.

The statement included several recommendations, the most important of which is the need for member states to exchange research findings on regional and national trends on extremism and violent extremism, regularly.

Participants condemned all forms and manifestations of extremism, regardless of its motives, stressing that violent extremism is one of the most serious challenges facing the world

today and poses a great danger to the lives of young people in particular.

They pointed out that violent extremism and terrorism are global challenges that are not limited to specific countries, ideologies or religions,

stressing the importance of evidencebased policy and interventions in com-

The recommendations also emphasised the need for collaboration between researchers, academics and

bating violent extremism.

policy makers in disseminating knowledge and best practices related to violent extremism, concerning its drivers, risk factors, methods of monitoring and measurement within communities as well as the means to address it.

The recommendations noted the importance of the relevant Security Council resolutions, in particular the two resolutions, which required closer co-operation between the research community and the United Nations Counter-Terrorism Committee, calling on member states to develop and implement risk assessment tools to identify individuals showing signs of violent extremism.

Participants cautioned that many member states face challenges in accurately assessing progress against violent extremism at the national and international levels, in part due to a lack of reliable data.

They stressed the need for further study of individual and social factors that serve as indicators of violent extremism, to better assess the effectiveness of existing strategies to combat extremism and to develop and implement better risk assessment tools and methodologies. The recommendations also called

for a gender-sensitive approach in line with United Nations Security Council resolution 2242 (2015) on the various roles women can play in efforts to prevent and combat violent extremism.

Director of SESRI Dr Hassan al-Sayed said the agreement to launch the index was an important achievement for the conference. SESRI is seeking to launch a survey-based index in many countries to measure the phenomenon of violent extremism, he added.

During the two-day conference, participants sought further exploration of variables at the individual and community levels, which could serve as indicators of the phenomenon of extremism, to fully assess the effectiveness of existing counter-radicalisation strategies and to develop and implement risk assessment tools and methodologies. ## UN official: Qatar backs global efforts in fight against terrorism

xecutive director of the Counter-Terrorism Com-**⊿** mittee Executive Directorate at the UN Michele Coninsx affirmed that Qatar is showing the international community that it is an active player in supporting global efforts to identify solutions to the challenge of combating extremism and

In an interview with a local newspaper on the sidelines of the International Conference on Studying the Causes of Extremism, Coninsx said that the conference focuses on the motives of extremism and discusses the causes of the phenomenon and wavs to deal with it.

"The fight against terrorism is closely linked to collective efforts at the global level, which made it effective and crucial to address the threats posed by terrorism," Al-Sharq quoted her as

Coninsx called on the inter-

national community to work together and to bring the terrorists to justice through legal procedures, stressing that terrorism and violent extremism can never be defeated by military means

She added that there are other factors that can address the phenomenon, including addressing the conditions conducive to the spread of terrorism, preventing extremism and terrorism, combating incitement to commit terrorist acts, respecting human rights and fundamental freedoms, promoting political and religious tolerance, good governance, economic development and social cohesion.

Coninsx noted that the involvement and exchange of information and lessons learned on the motives of extremism is important for member states given the complexity of this challenge and the fact that the motives of extremism may vary from country to country and region to region.

On the issues and themes of the conference, Coninsx said that the topics under discussion were relevant to the current development of the global terrorist threat, including the challenges posed by the return of foreign terrorist fighters and returnees from conflict zones to their countries, in particular, the way in which the causes of extremism work helps feed many of the current threats.

"The conference's focus on the motives of extremism is relevant to our collective efforts to effectively counter the threats posed by terrorism, including the return of foreign terrorist fighters," she noted.

The UN official stressed that understanding, discovering and addressing the drivers of extremism in violence is a critical element in this

### HMC teams perform six kidney, one liver transplants over five days

amad Medical Corporation's (HMC) transplant organ donation teams performed six lifesaving kidney transplants and one liver transplant over five days.

The organs for the record number of transplant operations came from four live, related donors and one deceased donor. The seven transplant patients represent residents from seven different nationalities - Qatari, Syrian, Bangladeshi, Tunisian, Yemeni, Filipino, and Egyptian.

Yousuf al-Maslamani, medical director, Hamad General Hospital, and director, Qatar Center for Organ Transplantation (QCOT), said the successful outcome of the 12 procedures is a testimony to the teamwork, resourcefulness and expertise of the organ donation and transplant teams.

"This team includes doctors, transplant co-ordinators, nurses, and support staff from different specialities across HMC," Dr al-Maslamani said, adding, "The result was six successful kidney transplants and one liver transplant, all life-changing procedures for our patients. We wish them all good health, and for the deceased donor, a blessing in heaven - whoever saves one, it is as if he had saved mankind entirely."

Dr Abdulla al-Ansari, acting chief medical officer, expressed his pride in the high standard, quality, and safety of care provided by the teams involved.

For his part, Dr Hassan al-Malki, head, nephrology department, said patients requiring transplant surgeries no longer need to look outside Oatar.

"HMC offers an excellent standard of care and the positive outcomes of transplant surgeries performed in the country encourages us to advise the public to have their surgeries and follow-up care here in Qatar. Here they will receive safe, effective, and compassionate care and can avoid going abroad for the unknown," said Dr al-Malki.

Dr Riadh Fadhil, director, Qatar Organ Donation Center (Hiba), added that Qatar has a successful and worldrecognised organ donation programme.

"We are so glad that the number of donated organs so far in 2019 has outnumbered that of last year. Our model of organ donation with a single unified waiting list - has become known for its efficiency, equity, and respect of human dignity. We are proud that it has become a model emulated by other nations," said Dr Fadhil. (QNA)
